**Farmers Market Rules and Regulations**

Friedrich's Farmers Market outdoor market opens May thru end of October. Sale days are the first Saturday of every month during the hours of 8AM – 12:00PM/sell-out. No products will be sold before 7:30AM.

**Vendor Fee:** The season will have at least (7 Saturdays (May 4; Jun 1; Jul 6; Aug 3; Sep 7; Oct 5 & 26):

- Vendor Fee \$30 per Saturday
- Vendor fees are payable up to 2 days prior to setup.
- Fees are non-refundable as we hold that space for you. We can process all your debit & credit cards for a \$1.50 transaction fee.
- EBT payments can be made inside the market.

**Vendor Space:**

One (1) 10' x 10' area (approx.) will be provided in our parking lot, sizes may vary slightly. Vendors must bring their own table, chairs and umbrella or tent. No electricity available at the moment.

Vendors are responsible for furnishing and setting up display, tent, tables/racks, table clothes, sacks, and money for change, and also keeping stalls clean during market and before leaving the area.

Please setup no later than 7:30am.

**Parking and vehicle access to the booth:**

Vendors will have vehicle access to setup before and after the market. All vehicles must be out of the market parking lot 15 minutes prior to opening. We have an overflow parking area behind the building where you can safely park. Accessible through our private alley.

**Products that may be sold:**

- Seasonal fresh fruits/vegetables (locally grown)
- plants/ greenhouse items
- baked goods in compliance with local regulations
- fresh (or dried) herbs and flowers
- hand crafted for the home, kitchen or garden
- prepared foods in compliance with the St. Joseph Department of Health

- Local honey, molasses, cider.
- Please No: jams or pickles - non-compete. Available in the market)
- Please No: live animals or Flea Market Items

**Vendor Responsibility:**

A vendor may sell by weights or units. If a scale is used, the vendor is responsible for using a scale approved by the Missouri Department of Weights and Measures.

Vendors' products should be priced comparable to other vendors and maintained throughout the day.

**If you have produce left over talk to us at the market, we will work with vendors to minimize any waste. We buy produce for the market also.** Prices should be posted and visible to the public.

Vendors are required, if applicable, to have a Missouri sales tax number and are responsible for collection and payment of Missouri State Sales Tax. Vendors should indicate if "Sales Tax Included" or "Sales Tax Added".

It is recommended you check to see if you need liability insurance for any of your products. The market carries public liability insurance for the market area to protect customers on behalf of the market. **The market is not responsible for damages, theft or loss of any kind of vendors' property.**

Vendors should present themselves in a professional and kind manner at all times. No alcoholic beverages will be permitted. No animals are permitted except for Seeing Eye dogs.
